
Managing Client Relationships: Retaining & Attracting Clients

Spotlight on Immigration

Afghanistan



Since 2021, we have provided a range of humanitarian immigration support to newly arrived Afghan refugees and their families, from hosting screening clinics to providing full representation on asylum and Temporary Protected Status applications. We are happy to report that our clients are now starting to receive positive grants of asylum.

Ukraine



Over the past two years, Cleary has also mobilized to assist Ukrainian refugees fleeing violence at home. Through these efforts, we have assisted dozens of Ukrainians with applying for and receiving Temporary Protected Status and employment authorization in the United States.

New York



We also continue to lend our resources to help refugees arriving in NYC with a host of immigration needs, including staffing the Mayor's Emergency Asylum Application Clinic, hosting pro se asylum clinics, and supporting individuals applying for their work authorization documents.



Spotlight on Voting Rights

Voting rights advocacy is a pillar of Cleary's civil rights and racial justice docket.

In partnership with the **ACLU Voting Rights Project**, the **UCLA Voting Rights Project** and the **ACLU of Kansas**, we recently filed a complaint in Dodge City, Kansas, alleging that, despite the city's significant and growing Latine population, Latine voters have been systematically prevented from participating in the democratic election process, with no Latine candidates of choice having been elected to the Dodge City Commission in over 20 years. We are litigating the case on an expedited timeline, with trial set for early 2024.

In this election year, we will also be gearing up to engage in Election Protection activities, staffing volunteer attorneys on nonpartisan hotlines to answer voter protection questions from around the country and engaging in poll monitoring work.


Well-Being
