Immigration

Representing immigrants and refugees is at the core of Cleary's pro bono practice, and we have devoted hundreds of thousands of hours in support of these efforts. Our immigration work includes asylum, habeas petitions, Special Immigrant Juvenile Status, Violence Against Women Act self-petitions, Deferred Action for Childhood Arrivals, T-Visas, U-Visas, Temporary Protected Status, refugee resettlement, cancellation of removal, adjustment of status, and naturalization. We work hard on behalf of our clients to obtain life-saving humanitarian immigration relief in the United States. The firm also litigates matters to uphold and defend the rights of immigrants to ensure that, once they are in the United States, they are guaranteed due process and access to justice.

FTCA Litigation

Cleary is committed to providing holistic support to our humanitarian immigration clients. For example, we have been working with a Russian/Ukrainian physician couple who faced prosecution and imprisonment as a result of their public opposition to the war with Ukraine. Upon fleeing to the United States, the couple fled Russia for the United States, where they were arrested and detained in Louisiana by ICE.

We have now successfully secured asylum for them and are currently working to adjust their status to lawful permanent residents. In addition, we are representing them in their Foreign Tort Claims Act cases with RFK Human Rights, asserting misconduct and negligent acts of immigration officers during their inhumane six-month ICE detention.

Cleary and RFK Human Rights are also representing a lawful permanent resident who was wrongfully deported back to the Gambia and suffered severe medical neglect as a result in a separate FTCA litigation.

Affirmative Asylum: Cleary is proud to continue its work representing dozens of Afghan nationals with their asylum claims and has already successfully secured asylum for a female journalist working for *The New York Times*, a former student of the American University in Kabul, and a displaced student now at Bard College.

Temporary Protected Status: Cleary is also committed to deploying its resources swiftly to meet the needs of communities in crisis, including assisting Ukrainian and Venezuelan nationals with pro se clinics to help prepare their Temporary Protected Status applications.

Thought Leadership: The firm has also actively engaged with numerous nonprofits and governmental bodies to brainstorm and troubleshoot efforts to respond to the increased numbers of new arrivals in our country and especially in New York City. We continue to bring thought leadership and technical expertise to these conversations, serving as a go-to firm for piloting new projects.




International Human Rights

- Embedding within a transitional justice team to provide legal and technical support in the implementation of a new governance framework in a nation that has been devastated by conflict
- Providing strategic litigation advice to the Vance Center's innovative human-rights-based Women in Prison project

Reproductive Rights



- Our longstanding partnership with the Center for Reproductive Rights encompasses legal projects that advance access to sexual and reproductive healthcare around the world.
- We have forged partnerships with the ACLU Reproductive Freedom Project, If/When/How, and others to support critical research in the wake of the *Dobbs* opinion.
- We are particularly proud of our work in Alabama, where we have worked with Pregnancy Justice to end the imposition of unconstitutional bail conditions on pregnant women and new mothers.
- We support various nonprofits with corporate and strategic litigation advice as they expand their activities in response to increasing restrictions on access to maternal and reproductive healthcare.



Gun Policy & Safety

Gun safety advocacy work has been a focus of Cleary's pro bono practice since the Sandy Hook school tragedy in 2012. Since those early days of engagement, we have worked on a range of matters to address this public safety epidemic, developing relationships with the leading organizations in this space, including the Brady Center, the Giffords Law Center, and Everytown for Gun Safety.

From our amicus brief in the U.S. Supreme Court case New York State Rifle and Pistol Association v. Bruen, which was cited in the dissent, to developing a critical report analyzing national legislation on the prohibition of firearms for violent hate crime offenders, to providing significant support in Soto v. Bushmaster, our commitment to pursuing a safer world for all is clear.

Criminal Justice & Reform

In all of our work on these complex issues, we aim to realize a more equitable justice system for all.



Criminal Justice & Reform

Policing Reform & Accountability

As part of our longstanding commitment to racial justice and policing reform, Cleary and the Washington Lawyers Committee recently filed a § 1983 civil rights action against a special police officer agency following an unprovoked and brutal assault on our client. The case raises concerns about the authority granted to special police officers in D.C. and the use of those agencies without community consent.

We are also co-counseling with The Bronx Defenders in a long-running class action lawsuit against the City of New York and the NYPD arising from their practice of illegally using and sharing information from sealed arrest records in defiance of privacy laws—a practice that disproportionately harms Black and brown New Yorkers. After we filed in 2018, the NY Supreme Court ordered the NYPD to overhaul its technological systems to end the practice after ruling the City was in violation of NY's sealing laws. The NYPD has appealed the remedial order giving force and effect to the preliminary injunction stopping the NYPD's systematic violation of sealing statutes and the First Department recently heard oral argument. We continue to litigate this matter and many others, working to ensure institutional accountability and long-term reform.

Post-Conviction Advocacy

Beyond achieving systemic change, Cleary is committed to providing holistic post-conviction representation to those charged with crimes. For example, we recently successfully appealed multiple armed robbery convictions on behalf of a client who has maintained his innocence throughout. As part of the appeal, the team litigated a petition for ineffective assistance of counsel, challenging the convictions based on our client's former defense counsel's failure to challenge deficient photo identifications and cellphone tracking evidence. The team consulted with a cell phone expert whose research revealed that our client's cellphone was several miles away from the scene of the alleged robberies.

The motion was recently granted, vacating our client's convictions. We supported the client in entering a plea agreement, which resulted in his release from prison. He is now living with family and has reintegrated into his community.



"Trial lawyers have to be fighters, and our team of litigators is fighting for a good cause. Private security guards acting under color of law not only didn't protect our client—they viciously attacked him in front of his small children. We are fighting to hold these officers and their employers accountable, while also advocating for reform, so that this does not happen to anyone ever again."

LGBTQ+ Rights

Our LGBTQ+ rights practice seeks to uplift, amplify, and protect the rights of LGBTQ+ communities both at home and abroad. Our work in this area is multi-faceted, spanning strategic litigation advice and individual representation in matters such as name changes, immigration, amicus briefs, and nonprofit formations, among other legal matters. At a time when queer and transgender rights are under political and social attack, Cleary is proud to stand with the trans, non-binary, and gender non-conforming community in asserting the fundamental rights and dignity of all people, regardless of their sexuality, gender identity, or gender expression.

Supporting LGBTQ+ Nonprofits

- We are assisting several nonprofits with formalizing their status as nonprofits and obtaining recognition of their tax-exempt status, including IraQueer, Pride Wide, and others.
- For example, we are assisting MJR Love with formalizing as a nonprofit and to secure tax-exempt status. MJR Love aims to provide education and training services to educators working to empower transgender and gender non-conforming youth and their allies.

Advancing Access to Civil Justice

Voting Rights

Voting rights advocacy is a pillar of Cleary's civil rights and racial justice docket. In late 2022, to support equal access to voting, Cleary Gottlieb, the ACLU Voting Rights Project, and the UCLA Voting Rights Project filed a federal lawsuit against Dodge City, Kansas, as well as the Dodge City Commission and its elected members, challenging the commission's at-large method for elections. Although the city's growing Latine population comprises 64% of the city's population and 59% of its voting-age population, there have been no Latine-preferred candidates elected since at least 2000.

The lawsuit argues that the at-large system dilutes Latine residents' voting power in violation of Section 2 of the Voting Rights Act and that it's possible to draw a single-member commission map providing Latine residents the opportunity to elect candidates of choice in at least two of the city's five districts.

The team engaged in a week long trial in February 2024 and is awaiting a decision.

This work enhanced my ability to discover the facts to advocate effectively for my clients, first taught me to marshal the work of a team of experts to support our clients' case, and provided early trial experience, including evidentiary motions, arguments, and witness examinations. Currently, I represent plaintiffs challenging an election system that denies their community equal opportunities to participate in the political process. Work to protect voting rights is essential, and I am appreciative of Cleary's support of this endeavor."

Supporting Families Seeking Education Accommodations

Cleary partners with **Mobilization for Justice** and **Advocates for Children** to fight for children with disabilities to have access to legally required educational supports. We work with parents in multiple languages to bring successful claims against the NYC Department of Education (DOE) on behalf of their children, challenging the DOE's failure to provide a free and appropriate public education.

Most recently, we successfully advocated on behalf of Spanish-English bilingual twin siblings with severe learning impairments, who were denied an appropriate public education, by respectively securing for each child 700 hours and 800 hours of compensatory tutoring. Because of our quick successes in these cases, the twins' parents are now considering bringing a case on behalf of their third child who has faced similar challenges in accessing educational supports.

Advocating for Survivors of Gender Violence

Cleary Gottlieb has a long-standing and vibrant pro bono practice supporting gender violence survivors. Our work in this area includes representing clients in petitioning for civil protection orders, assisting trafficking survivors seeking post-conviction relief, and filing amicus briefs in Hague Child Abduction Convention cases on behalf of domestic violence survivors who have had to flee their countries to protect themselves and their children from their abusers.

Most recently, Cleary is proud to participate in Sanctuary for Families' Narkis Golan International Child Abduction Initiative. Named in memory of a courageous Sanctuary client, the Initiative is dedicated to increasing access to justice for gender-based violence survivors involved in international parental abduction cases. Through this initiative, the firm supports Sanctuary in conducting screenings and intakes of potential clients, working to assess their potential Hague Convention claims, and identifying ways to keep them and their children safe.

Cleary Gottlieb's Public Interest Fellowship

The firm is exceptionally proud of the Cleary Gottlieb Fellowship Program, which enables New York-based first-year associates to pursue one-year placements at our legal services partner organizations in an effort to support the delivery of critically needed legal work to underserved communities. Cleary Fellows work across a broad range of practice areas with host organizations, including the ACLU Voting Rights Project, Acumen, the Clooney Foundation for Justice, Legal Services NYC, the Office of the Appellate Defender, Start Small Think Big, and The Legal Aid Society.






