

# **Promoting Justice**

#### **Rikers Island Sexual Abuse Litigation**

Cleary represents clients in a Section 1983 suit against NYC and a corrections officer at Rikers alleging repeated rape and sexual abuse, facilitated by a series of practices that fail to adequately protect women detained by the City. In addition to seeking damages for the named plaintiffs, the action also aims to eradicate the pervasive culture of sexual abuse in the jail. 

**College Advising:** Help students with college applications, financial aid and college readiness


