
Private Funds Paralegals provide comprehensive support to the firm's global private funds team and are responsible for handling a wide variety of client and team-driven tasks. This specialized position provides in-depth exposure to corporate law and the private equity industry and is an excellent learning opportunity for those interested in attending law school, attending business school, or pursuing other career goals.

Within the private funds practice, Cleary advises on a wide variety of matters, such as:

- **Fund Formation**
The firm advises sponsors in the formation of a variety of domestic and international funds, including private equity, growth, credit, venture capital, conduit, social impact, and co-investment funds, and other alternative asset management vehicles.
- **LP Investments**
The firm advises LPs in their investments in private funds.
- **Investments in Sponsor Businesses**
The firm advises on investments in sponsor businesses, including the acquisition of GP stakes, cornerstone investments, and sponsor JVs.
- **Secondary Transactions**
