## **EU Implements Strengthened Iran Sanctions**

On March 23, 2012, the Council of the European Union adopted Council Regulation (EU) No 267/2012 ("Regulation 267/2012")<sup>1</sup>, which implements the restrictive measures against Iran imposed by Council Decision 2012/35/CFSP<sup>2</sup> of January 23, 2012, and Council Decision 2012/152/CFSP<sup>3</sup> of March 15, 2012. The Council also prohibited the export of telecommunications monitoring equipment for use by the Iranian regime through Council Regulation (EU) No 264/2012 ("Regulation 264/2012").<sup>4</sup> Regulation 267/2012 consolidates the pre-existing measures and the newly enacted measures into a single legislative text, with Regulation 264/2012 separately dealing with a specific additional measure.

This memorandum highlights the most important amendments to the EU's Iran sanctions program, but does not attempt to summarize those pre-existing sanctions measures that remain applicable.<sup>5</sup>

#### 1. OIL, NATURAL GAS, AND PETROCHEMICAL PRODUCTS

Regulation 267/2012 implements the Council's decision to prohibit the sale, supply, transfer or export to any Iranian person, entity or body or for use in Iran of further key equipment and technology, which could be used in key sectors in the oil, natural gas, and petrochemical industry.<sup>6</sup> Any new investment in these sectors is also

prohibited.  $^7$  A list of affected "crude oil and petroleum products" is included in Annex IV to Regulation 267/2012 and a list of targeted "petrochemical products" is included in Annex V.

An exemption is provided for contracts concluded before January 23, 2012 and to be executed before July 1, 2012, in the case of oil and petroleum products, or May 1, 2012, in the case of petrochemical. To benefit from these exceptions, an entity seeking to perform a contract must notify its home Member State authority at least 20 working days in advance.

#### 2. FINANCIAL MESSAGING SERVICES (SWIFT)

The Council prohibited the supply of specialized financial messaging services to any financial institution subject to the EU's Iranian sanctions (including the Central Bank of Iran, Bank Tejarat and Bank Melli). For this reason, with effect from March 17, 2012, SWIFT has disconnected these institutions from its financial messaging services, effectively blocking any international wire transaction to the affected banks, regardless of the jurisdiction of the parties involved in the transaction. 11

### 3. PRECIOUS METALS

Regulation 267/2012 prohibits any direct or indirect trade in gold, precious metals and diamonds with the Government of Iran, its public bodies, corporations and agencies, any person, entity or body acting on their behalf or at their direction, or any entity or body owned or controlled by them. <sup>12</sup> This prohibition includes any form of financial or technical assistance related to these goods.

#### 4. TELECOMMUNICATIONS

Finally, according to Council Regulation (EU) No 264/2012, which relates to the human rights situation in Iran, the supply of key equipment, technology and software capable of monitoring or intercepting internet or telephone communications to any person, entity or body in Iran or for use in Iran, as well as assistance in installing,

operating or financing such equipment or software, requires prior government approval. The relevant equipment is described in Annex III to Regulation (EU) 264/2012.
